

**RESOLUTION NO. 2020- 95**

**RESOLUTION OF THE BOARD OF DIRECTORS OF THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT SETTING THE SPECIAL TAX RATE FOR SERVICE ZONE FP-5 FOR FISCAL YEAR 2020-21**

On Tuesday, June 9, 2020, on motion of Director Gonzales, duly seconded by Director Lovingood and carried, the following resolution is adopted by the Board of Directors of San Bernardino County Fire Protection District.

SECTION 1. The Board of Directors of the San Bernardino County Fire Protection District hereby finds and determines:

- a) That on August 1, 2006, the electors of Service Zone FP-5 (formerly known as County Service Area 70, Improvement Zone FP-5) (Helendale/Silver Lakes) duly authorized a special tax levy for financing fire protection services.
- b) That the original amount of such tax was \$117 per parcel, per year with an annual 3% cost of living increase for Service Zone FP-5.
- c) Between August 1, 2006 and October 16, 2018, Service Zone FP-5 was expanded to include Needles, Twentynine Palms, San Bernardino, Upland and San Antonio Heights.
- d) In 2019, the trial court in *San Antonio Heights Association v. LAFCO*, San Bernardino County Superior Court Case No. CIVDS 1712771 ruled that while the annexation of the Upland into San Bernardino County Fire Protection District was valid, the annexation of Upland and the unincorporated area of San Antonio Heights into FP-5 was not. This judgment covered the special taxes levied in Fiscal Years 2017-18 and 2018-19.
- e) That on October 16, 2018, the Board of Directors adopted a resolution that expanded the boundaries of Service Zone FP-5, including, but not limited to, Upland and San Antonio Heights.
- f) That the current area of Service Zone FP-5 is described in Attachment A to this resolution. Attachment A is incorporated into this resolution by reference.

SECTION 2. The Board of Directors of the San Bernardino County Fire Protection District, therefore, hereby resolves and orders:

- a) That the special tax for Service Zone FP-5 for Fiscal Year 2020-21 shall be set at \$157.26 per parcel.
- b) That following the adoption of this resolution, the Secretary of the Board of Directors shall cause a copy of same to be published once in a newspaper of general circulation within Service Zone FP-5.
- c) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the special tax for Service Zone FP-5 on the 2020-21 tax roll.

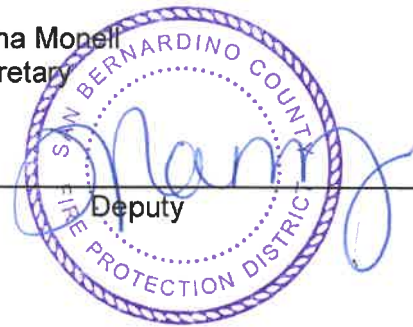

### **EXPANSION OF BOUNDARY FOR SERVICE ZONE FP-5 OF THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT**

All of the unincorporated territory in the County of San Bernardino, State of California, together with those portions of lands lying within the incorporated boundaries of the following Cities:

City of Grand Terrace (as described in LAFCO Action 3000);  
Town of Yucca Valley(as described in LAFCO Action 3000);  
City of San Bernardino (as described in LAFCO Action 3198);  
City of Needles (as described in LAFCO Action 3206);  
City of Upland including the unincorporated portions of San Antonio Heights (as described in LAFCO Action 3216);

Also together with those portions of lands lying within the boundaries of the following Districts:

Helendale Community Services District (as described in LAFCO Action 3175);  
City of Twentynine Palms Walter District (as described in LAFCO Action 3200);

Also together with the **Annexation Area** known as the Crest Forest Fire Protection District (as described in LAFCO Action 3186). Said annexation area containing 11,215Acres more or less.

Excepting therefrom those portions of lands lying within the incorporated boundaries of the following Cities:

City of Chino Hills;  
City of Montclair including its Unincorporated Sphere of influence;  
City of Ontario;

Running Springs Water District;

Newberry Springs Community Services District;  
Rancho Cucamonga Fire Protection District;

Big Bear Lake Fire Protection District;  
Hesperia Fire Protection District;  
Barstow Fire Protection District;  
Arrowbear Park County Water District;  
Big Bear City Community Services District;  
Baker Community Services District;  
Daggett Community Services District; and,  
Rubidoux Community Services District.

The total expansion area of the Service Zone FP-5 of the San Bernardino County Fire Protection District contains 12,207,306 acres (19,073 Square Miles) more or less.
